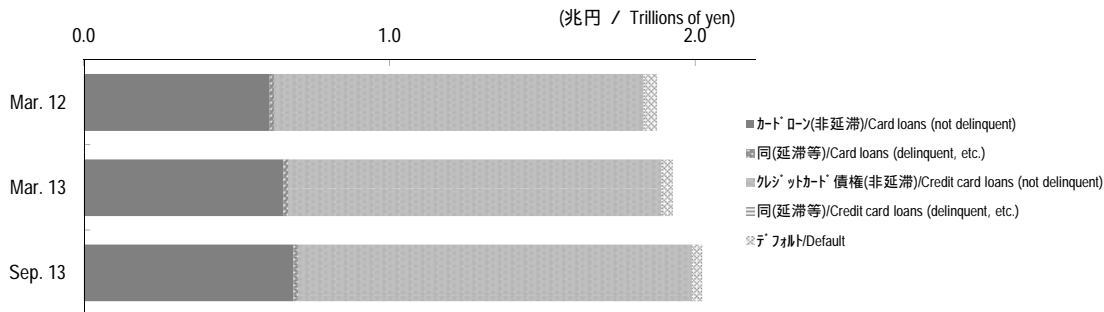

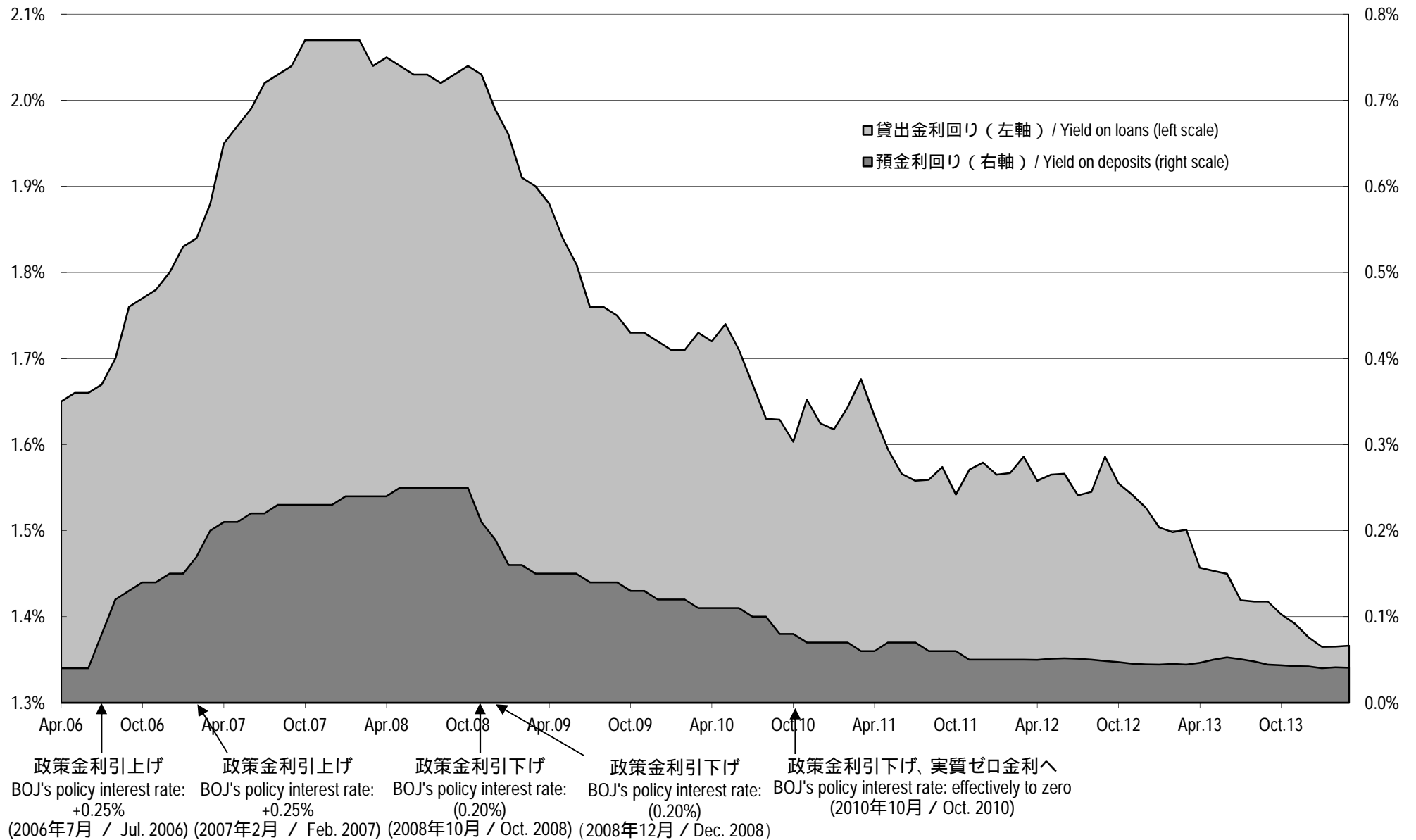

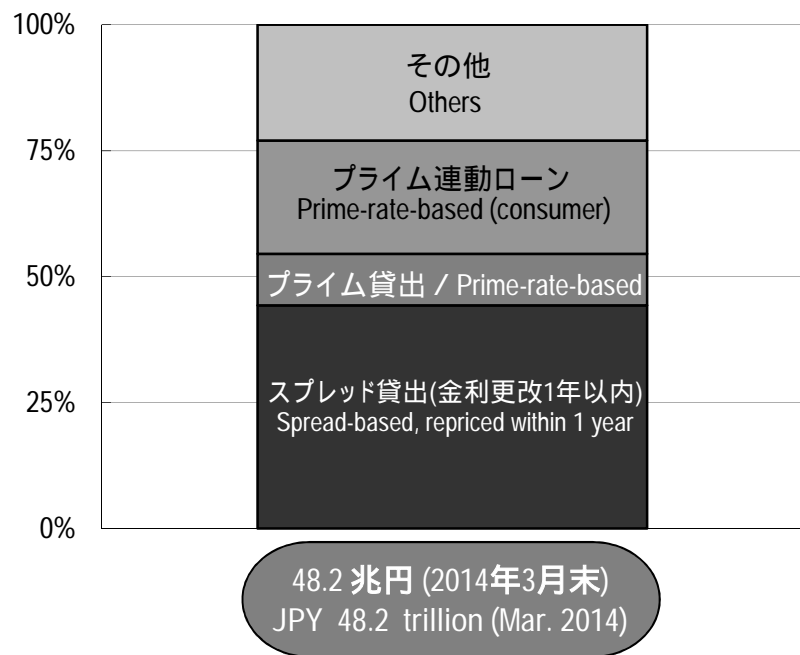

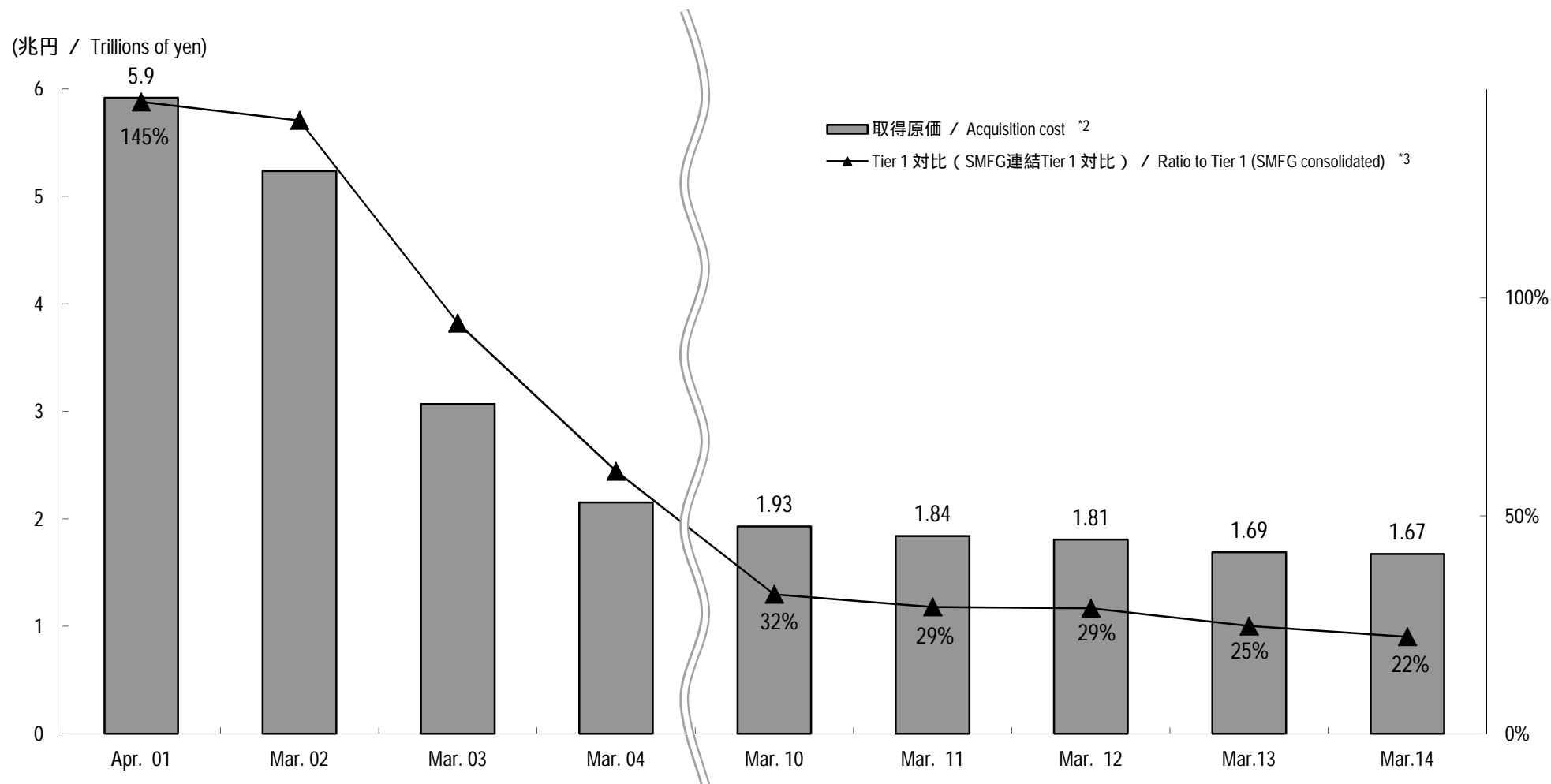

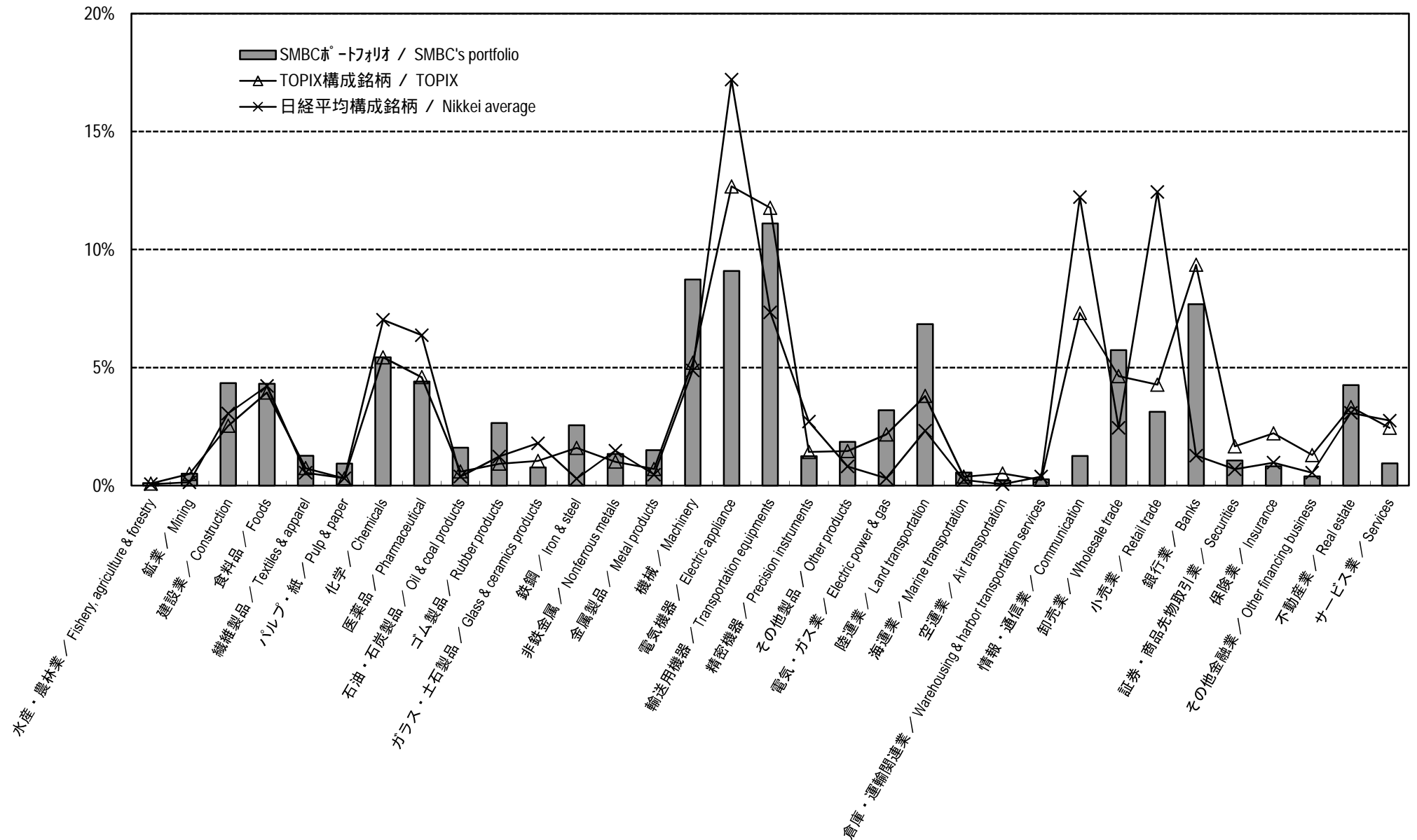

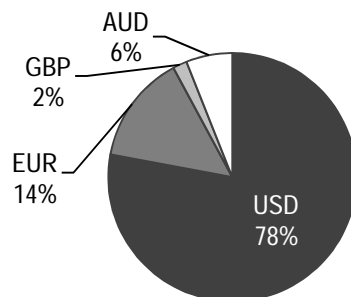

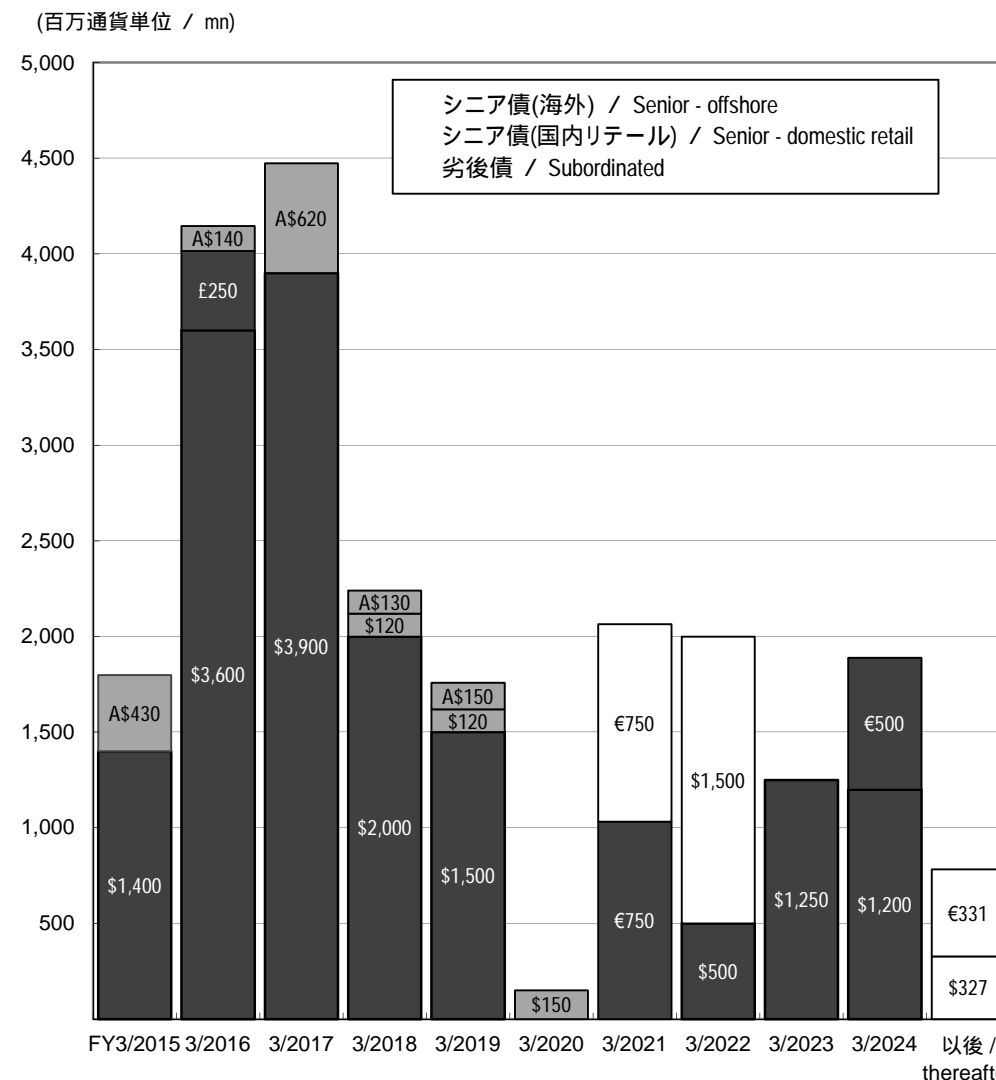
通貨別内訳 / Currency breakdown

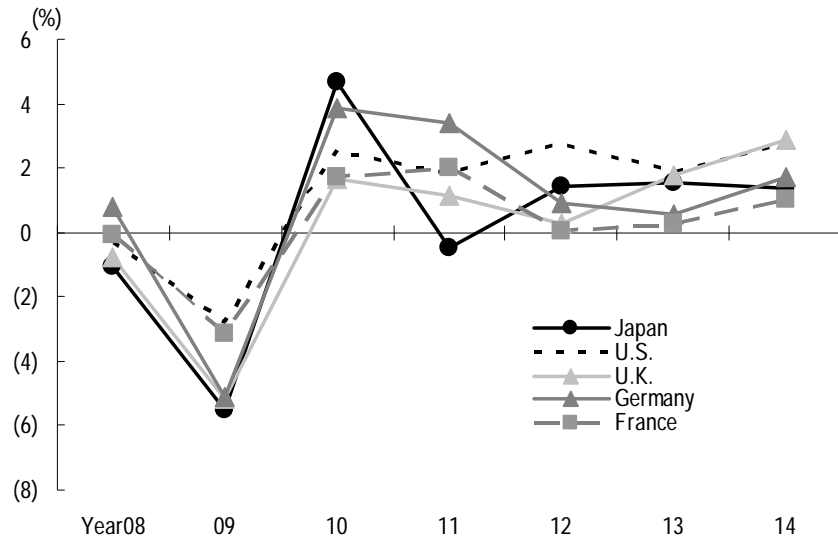

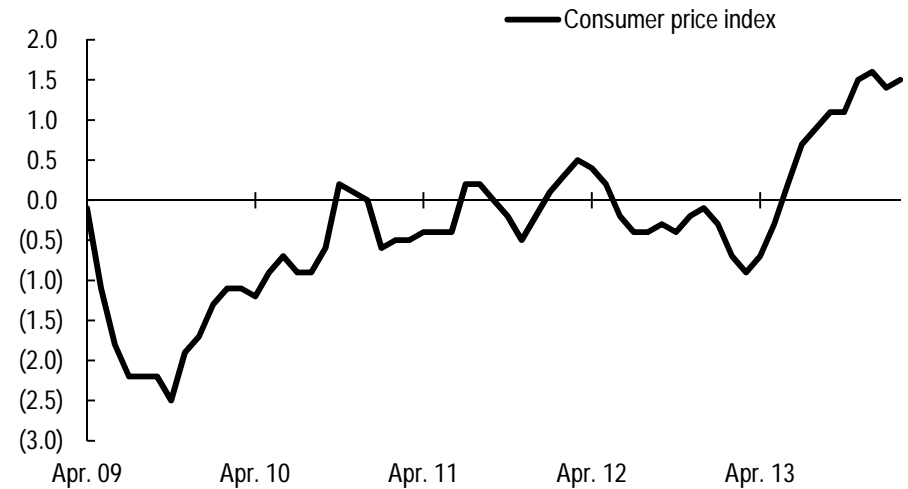
実質GDP成長率 / Real GDP growth rate

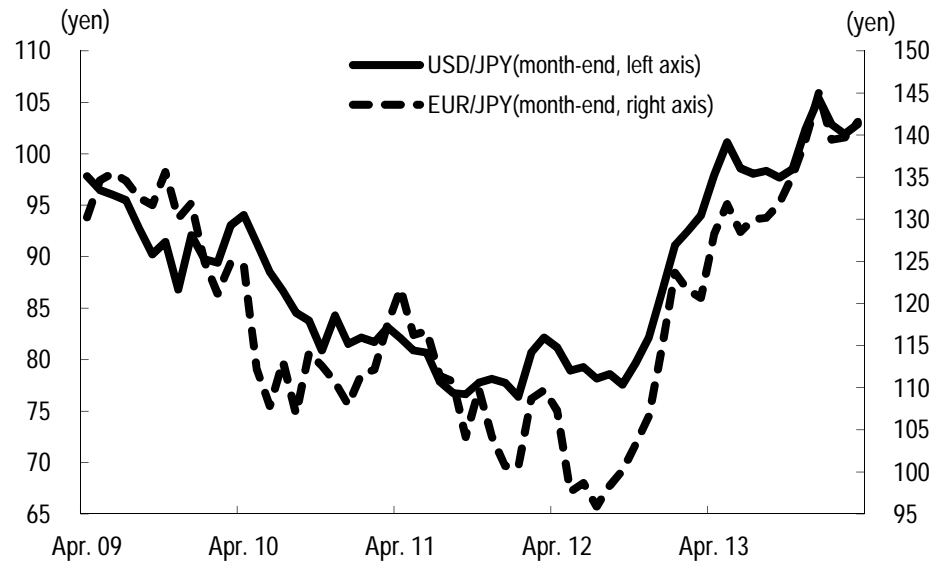

消費者物価指数(前年同期比) / Consumer price index (YOY change)

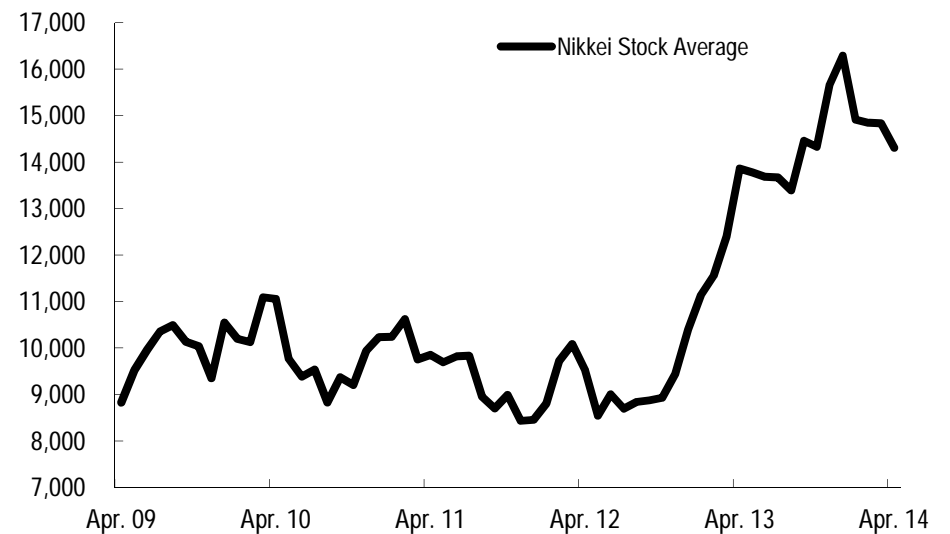

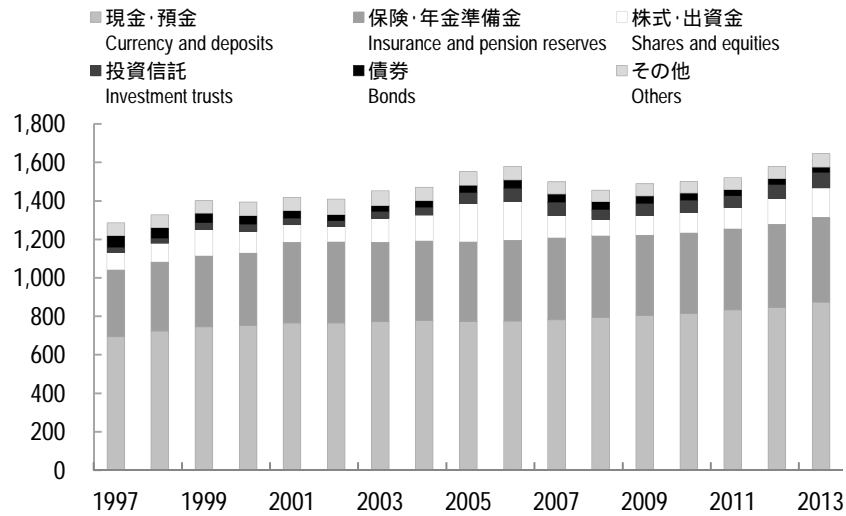

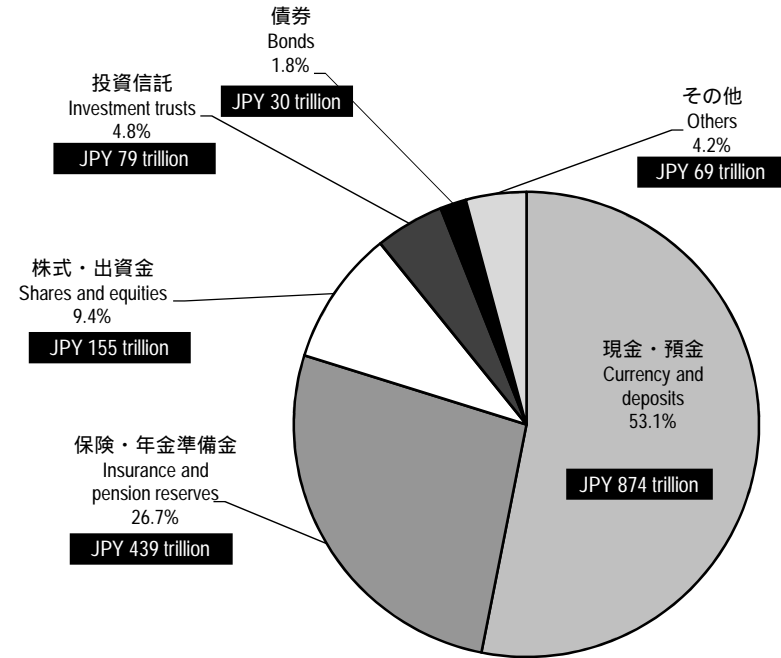

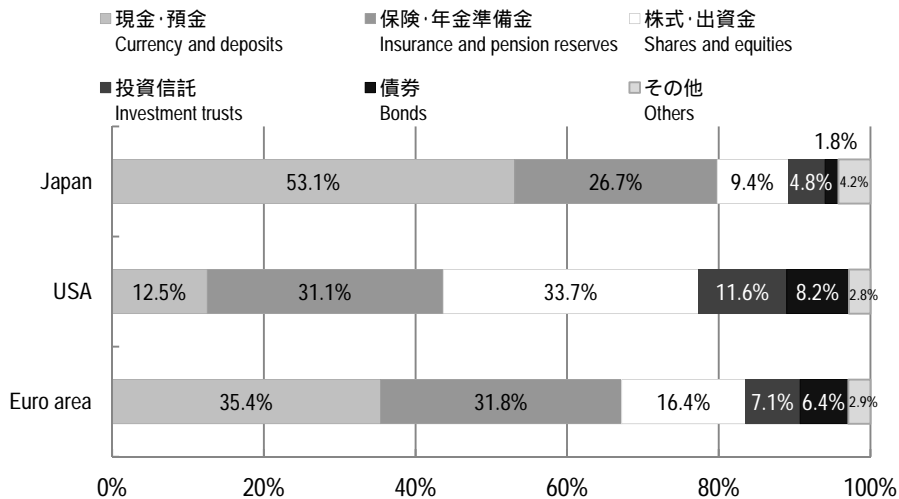

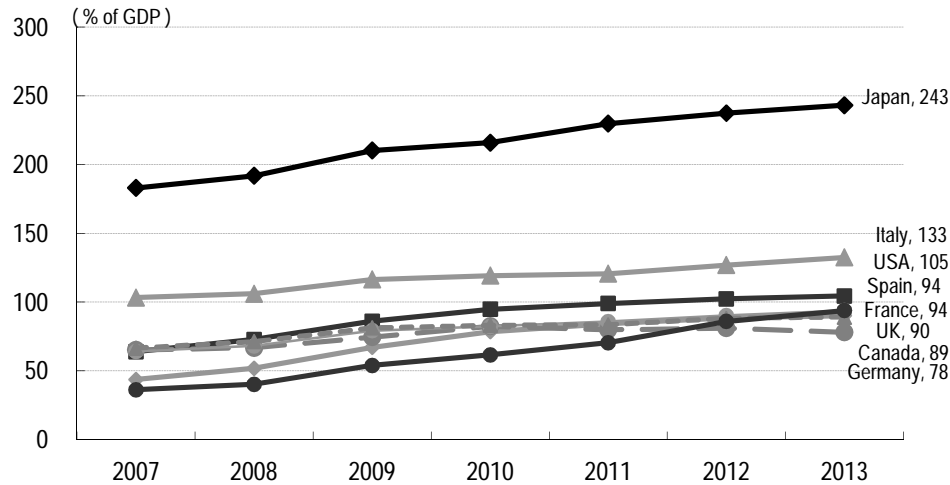
個人金融資産構成の国際比較 / Comparison of households' financial assets

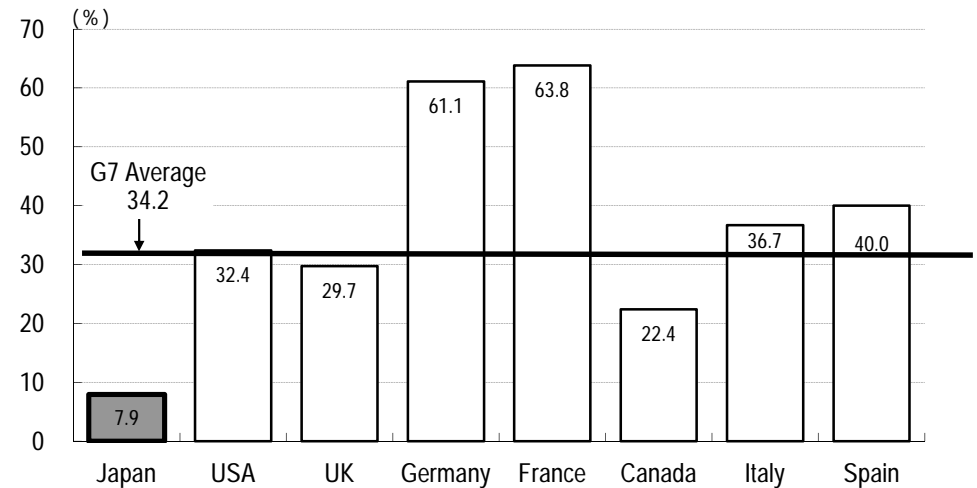
政府債務残高 General government gross debt

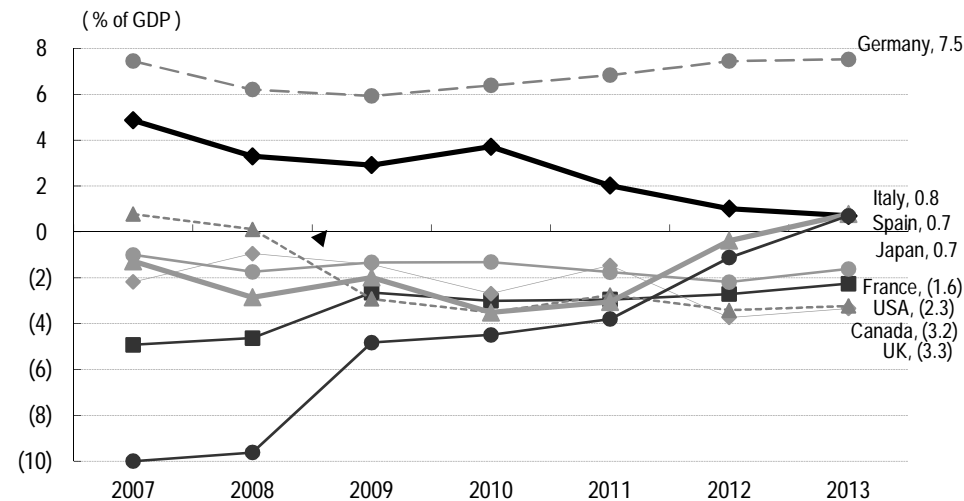

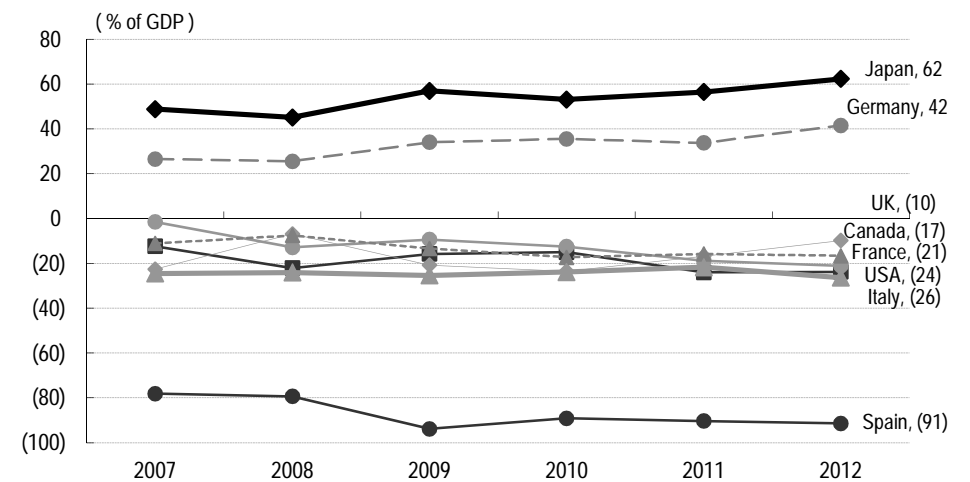
経常収支 Current account balance
