This report aims to help all stakeholders understand how the SMBC Group enhances corporate value under its long-term Vision. We provide integrated disclosure of both financial and non-financial information.

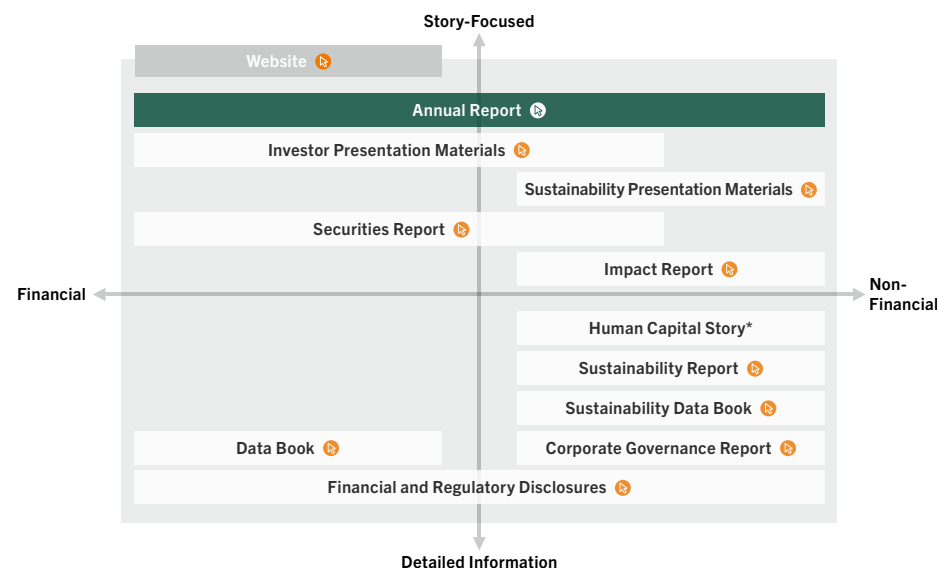
